for any purposes on such premises; that it will not use such premises for any other purpose than that authorized in this lease, and that before abandoning any well it will securely plug the same so as to effectually shut off all water above the oil bearing horizon.

And it is mutually understood and agreed that no sublease, assignment, or transfer of this lease or of any interest therein or thereunder can be directly or indirectly made without the written consent thereto of the lessor and the Secretary of the Interior first obtained, and that any such assignment or transfer made or attempted without such consent shall be woid.

And the said party of the second part further covenants and agrees that it will keep an accurate account of all oil mining operations showing the whole amount of oil mined or removed and all sums due as royalty shall be a lien on all implements, tools, movable, machinery, and other personal chattels used in said prospecting andmining operations, and upon all of the oil obtained from the land herin leased, as security fot the payment of said royalties.

And the party of the second part agrees that this indenture of lease shall in all respects be subject to the rules and regulations heretofore or that may hereafter be lawfully prescribed by the Secretary of the Interior relative to oil and gas leases in the Cherokee Nation.

And the said party of the second part expressly agrees that should it or its sublessees, hers, executors, administrators, successors or assigns, Violate any of the evenants, stipulations, or provisions of this lease, or fail for the period of sixty days to pay the stipulated monthly royal ty provided for herein, then the party of the first part shall be at liberty to in its discretion to avoid this indature of lease and cause the same to be annulled when all the rights, franchises and privileges of the party of the second part, its, sublesses, heirs, executors, administrators, successors, or assigns hereunder shall cease and end without further proceedings.

If the lessee makes reasonable and bona fide effort to find and produce oil in paying quantity as is herein required of kim it and such effort is unsuccessful it may at any time thereafter with the approval of the Secretary of the Interior, surrender and wholly terminate this lease upon the full payment and performance of all its then existing obligations hereunder: Provided, however, th that approval of such surrender by the Secretary will be required only during the time his approval of the alienation of the land is required by law.

It is further agreed and understood that thislease shall be of no force or effect unless the party of the second part shall, within sixty days from the date of approval of the application filed in connection herewith furnish a satisfactory bond in accordance with the regulations of May 4, 1903, prescribed by the Secretary of the Interior, which shall be deposited and remain on file in the Indian Office during the life of this lease.
