

possessed of the following described tract of lands situated in the County of Tulsa, State of Oklahoma, to-wit:

The Southwest Quarter ($\frac{1}{4}$) of Section One (1), Township Nineteen (19) North, Range Thirteen (13) East of the Indian Meridian, containing One Hundred Sixty (160) acres, more or less.

said minor being a one-quarter ($\frac{1}{4}$) blood citizen of the Creek Tribe of Indians, having become possessed of the above described land as such citizen.

The Court further finds that upon the 28th day of March, 1910, the said petitioner, on behalf of said minor, made and executed a certain oil and gas mining lease, embracing the lands above described, to Archibald Campbell, of Tulsa, Oklahoma under and by virtue of the terms of which lease the consideration paid therefor and thereunder is the sum of One Hundred Sixty Dollars (\$160.00), the royalty to be paid thereunder is one-eighth ($\frac{1}{8}$) of the oil produced, and Two Hundred Dollars (\$200.00) per annum for each gas well found on said lands, so long as gas is sold therefrom; that by the terms of said lease, a well is to be completed upon said premises within six (6) months after the date thereof, or if no well is completed within six (6) months from the date of said lease the lessee is to receive the sum of One Dollar (\$1.00) per acre semi-annually in advance after the expiration of said six months; all of which fully appears from a true and correct copy of said lease attached to said petition herein. And the court further finds that the said consideration received, the royalty to be paid, and all the terms of said lease, are fair and reasonable, and as good as can be obtained, and that it is for the best interests of said minor that said lease be approved.

Wherefore, it is by the court ordered, considered, and adjudged and decreed that the said lease be and the same is hereby ratified, approved, confirmed and declared valid, and the action of the said petitioner, John C. Chamberlain, in making and executing said lease for and on behalf of said minor, as Guardian of said minor, is hereby approved; and said John C. Chamberlain, guardian of said minor, is hereby directed to deliver to said Archibald Campbell the said lease.
