Whereas, Samuel W. ^{Brown} Jr. an allottee of the Creek Nation, has made application for the removal of restrictions from the following described land, to-wit:

Northeast Quarter (NE4) of northeast Quarter (NE4) of Section Twenty-two (22) Township Seventeen (17) North, range Twelve (12) East of the Indian Base and Meridian, containing 40 acres, more or less.

Now, Therefore, I, Under the authority vested in me by the act of Congress approved May 27, 1908 (Public No. 140) and the regulations prescribed thereunder, hereby remove the restrictions from said above described land without conditions
