ORDER OF COURT APPROVING LEASE.

Now on this 22nd day of June, 1910 comes Alice Jack, the duly appointed, qualified and acting guardian of the person and estate of Alice Luvina Jack, a minor, and reports to the court that she, as such guardian, has duly executed to the Producers Oil Company, an oil and gas mining lease upon the following described lands of said minor, situate in Tulsa County, Oklahoma, to-wit:

The North west quarter ($\frac{1}{4}$) of the Northeast Quarter ($\frac{1}{4}$) of Section Thirty one (31) in Township Nineteen (19) North, Range Thirteen (13) East, containing forty (40) acres more or less.

And the said guardian files with her said report the lease aforesaid and the court, after due inspection and examination thereof, finds that said lease conforms in all things to the order of the Court directing and authorizing the execution thereof and that the same ought to be confirmed and approved.

It is therefore, by the court, considered, ordered and adjudged that the said lease of the said Alice Jack, guardian as aforesaid, made and entered into with the said Producers Oil Company, bearing date of June 22nd, 1910, and being for a term expiring on the 8th day of February, 1918, but in no event to extend beyond the minority of said minor, be and the same is hereby ratified, confirmed and in all things approved.
