DEED OF ADMINISTRATION

THIS INDENTULE, Made the 22nd day of June, 1910, by and between Marie Buel, the duly appointed, qualified and acting Administratrix of the estate of Frank W. Buel, deceased, party of the first part, and Frank M. Rodlof, the party of the second part:

WITNESSETH: That whereas, on the 21 day of May, 1910, the County Court of the County of Tulsa, State of Oklahoma, made an order of sale authorizing the said party of the first part to sell certain real estate of the said Frank W. Buel, deceased, situated in the city of Tulsa, County of Tulsa, Oklahoma,, and specified and particularly described in said order of sale, which said order of sale now on file and of record in the said county Court, is hereby referred to and made a part of this indenture, and

NOW, THEREFORE, The said wrs. Marie Buel, administratrix of the estate of Frank W. Buel, deceased, as aforesaid, the party of the first part, pursuant to the order last aforesaid of the said County Court, for and in consideration of the sum of Four Thousand (\$4,000.00) dollars to her in hand paid by the said party of the second part, receipt whereof is hereby acknowledged, has granted, bargained, sold, and conveyed and by these presents does grant, bargain, sell and convey unto the said second part Frank M. Rodolf, his heirs and assigns forever, all the right, title, interest and estate of the said Frank W. Buel, deceased, at the time of his death, and also all the right, title, and interest that the said estate by operation of law or otherwise, may have acquired, other than, or in addition to, that of said intestate at the time of his death, in and to all that certain, lot, piece or parcel of land situated, lying and being in said City and County of Tulsa, State of Oklahoma, and bounded and described as follows, to-wit:
