WITNESSETH: Whereas on the on the 7th day of April, 1910, an execution was issued out of the District Court of Tulsa County, Oklahoma, under the seal of said court, and signed by the clerk thereof, upon a judgment recovered in said court on the 12th day of January 1907, in favor of T.E. AND Whereas, the said Sheriff on the 6th day of June, 1910, at ten o'clock A.M. at the front door of the courthouse of Tulsa County, Oklahoma, offered all said realestate for sale to the highest and best bidder for cash in hand, and the highest and best bid being made by J.W. Orr, who bid the sum of \$1500.00 said land was sold to him.

AND Whereas, on the 29th day of June, 1910, the said Sheriff made his return to said execution into said court, with a full statement of his proceedings endorsed thereon;

AND whereas, on the 29th day of June, 1910, the District Court of Tulsa County, Oklahoma, carefully examined the proceedings of such sheriff under said execution; the court was satisfied that the sale had in all respects been made in conformity with, and under the provisions of Article 19, Chapter 87, of the Compiled Laws of Oklahoma of 1909, and directed the clerk of the said District Court to make and enter on the journal of said court, that the court is satisfied as to the legality of said sale, an order that said shariff make to said purchaser, J.W. Orr, a deed of said lands, and tenements;
