 State of Oklahoma, to-wit: This undivided 1/4 interest in and to the Southeast
1/4 of Section 16, Township 16 North Range 13 east, Containing
in all 40 acres more or less, as the case may be according
to the U.S. Govt Survey thereof. Same being the allotment
of Short Frank Deceased

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in
 any wise appertaining forever.

 for heirs, executors or administrators, do hereby covenant, promise and agree to and with said party of the second part,
 that at the delivery of these presents, that she is lawfully seized in her own right of an absolute and infeoffable
 estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises, with the appurtenances;
 that the same are free, clear, discharged and unencumbered of and from all former grants, titles, charges, judgments, taxes, assessments and
 incumbrances, of what nature and kind soever;

and that she will warrant and forever defend the title to the same unto said party of the second part, heirs and assigns,
 against said party of the first part, their heirs, and all every person, whomsoever, lawfully claiming or to claim the same.
