COMPAVED

This Indenture, made this 20th day of August A. D. 1910,
between O. Leonard and Eva M. Leonard his wife of Ellis

Tulsa County, in the State of Oklahoma, of the first part, and

John L. Powell and N. J. Gessler Trustees

of the second part.

WITNESSETH, The said parties of the first part, in consideration of the sum of One dollar and other good and valuable considerations and Dollars, the receipt whereof hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said parties of the second part, their heirs and assigns, all of the following described real estate, situated in the County of Tulsa and State of Oklahoma, to-wit:

Lot seventeen 17 eighteen 18 nineteen 19 twenty 20 and a strip eight (8) feet wide off the east side of lot number sixteen (16) in Block number five (5) in Burnett Addition to the City of Tulsa as shown by the recorded plat thereof.

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining forever.

And said grantors, for themselves and for their heirs, executors or administrators, do hereby covenant, promise and agree to and with said parties of the second part, that at the delivery of these presents they are lawfully seized in their own right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises, with the appurtenances; that the same are free, clear, discharged and unencumbered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever; subject to a certain contract for a deed running to J.W. Marshall, and that they will warrant and forever defend the title to the same unto said parties of the second part, their heirs and assigns, against said parties of the first part, their heirs, and all every person whomsoever, lawfully claiming or to claim the same.
