that at the delivery of these presents he is lawfully seized in his own right of an absolute and inde-
feasible estate of inheritance, in fee simple, of to and all and singular the above granted and described premises, with the appurtenances;
that the same are free, clear, discharged and unencumbered of and from all former grants, titles, charges, judgments, taxes, assessments and
incumbrances, of what nature and kind soever; except a certain gas lease, dated November
1st, 1910.

against said part of the first part his heirs, and and every person whomsoever, lawfully claiming or to claim the same.
