

## Deed Record, No. 87, Tulsa County.

*This Indenture, Made this 10th day of October  
between Edward A. Klate, a single man*

*Tulsa County, in the State of Oklahoma, of the first part, and Alice Jack*

*of the second part.*

WITNESSETH, The said part of the first part, in consideration of the sum of Four Thousand Sixty one and 90/100 Dollars and other good and valuable Consideration Dollars the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said part of the second part, her heirs and assigns, all of the following described real estate, situated in the County of Tulsa and State of Oklahoma, to-wit: Easterly, one half of lot three (3) of the subdivision of Lot Seven (7) Block One hundred and thirty six (136) of the City of Tulsa, Tulsa County, Oklahoma according to the original Government Survey of said thereof laid subdivision being according to the plat thereof filed for record in the office of the Register of Deeds of Tulsa County, Oklahoma on November 17-1909 being more particularly described as follows: Beginning at the northeast corner of said lot seven (7) in Block one hundred and thirty six (136) of said City of Tulsa, Tulsa County, Oklahoma according to the said Government Survey; thence southerly along the eastern line of said lot seven (7) eighty (80) feet; thence westerly at right angles with the easterly line of said lot seven (7) Twenty (20) feet; thence northerly parallel with the easterly line of said lot seven (7) eighty (80) feet to the north line of said lot seven (7)

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining forever.

And said Edward A. Klate, a single man for his heirs, executors or administrators, do hereby covenant, promise and agree to and with said part of the second part, that at the delivery of these presents he is lawfully seized in his own right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises, with the appurtenances; that the same are free, clear, discharged and unencumbered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever;

and that he will warrant and forever defend the title to the same unto said part of the second part heirs and assigns, against said part of the first part their heirs, and and all every person whomsoever, lawfully claiming or to claim the same.
