This Indenture, Made this 29th day of October A. D., 1922

WITNESSETH, The said part 1 of the first part, in consideration of the sum of \$2000

the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said part 2 of the second part,  
his heirs and assigns, all of the following described real estate, situated in the County of Tulsa and  
State of Oklahoma, to-wit:

South West Quarter (1/4) of Section  
Four (4) Township Nineteen (19)  
Range Fourteen (14) East

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in  
any wise appertaining forever

for their heirs, executors or administrators, do hereby covenant, promise and agree to and with said part 2 of the second part,  
that at the delivery of these presents are lawfully seized in their own right of an absolute and inde-

that the same are free, clear, discharged and unincumbered of and from all former grants, titles, charges, judgments, taxes, assessments and  
incumbrances, of what nature and kind soever;

and that their will warrant and forever defend the title to the same unto said part 2 of the second part — heirs and assigns,  
against said part 1 of the first part — their heirs, and and all every person whomsoever, lawfully claiming or to claim the same.
