 for their heirs, executors or administrators, do hereby covenant, promise and agree to and with said part us of the
 second part, that at the delivery of these presents they are lawfully seized in their own right of an absolute and indefeasible estate

 clear, discharged and unincumbered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what nature and
 kind soever;

and that us will warrant and forever defend the title to the same unto said part us of the second part his heirs and assigns,
 against said part us of the first part their heirs and all and every person whomsoever, lawfully claiming or to claim the same.
