Know all Men by these Presents, THAT I, L. K. Cone  
and Edith M. Cone his wife, of Tulsa in  
Western District of Indian Territory for and in consideration of the sum of  
Two Thousand and no/100 DOLLARS,  
to them in hand paid by John W. Overstreet guardian of William Bittle a minor  
the receipt whereof is hereby acknowledged, have Granted, Bargained and Sold, and do hereby Grant, Bargain, Sell and Convey unto the said John W. Overstreet  
guardian aforesaid, and unto his heirs and assigns, the following described real estate situated in  
The north sixty (60) feet of Lot nineteen (19) in The Bayne Addit-  
ion to Tulsa Indian Territory

TO HAVE AND TO HOLD THE SAME unto the said John W. Overstreet guardian of William Bittle a minor  
and assigns forever, with all the privileges and appurtenances thereto belonging.

And we, the said L. K. Cone and Edith M. Cone for  
ourselves and our heirs, executors, administrators and assigns, covenant with the said John W. Overstreet guardian aforesaid  
his heirs and assigns, that they are lawfully seized in fee of the aforesaid premises; that they are free from all incumbrances; that they have good  
right to sell and convey the same to the said John W. Overstreet guardian of William Bittle a minor as aforesaid; and that they  
will and their heirs, executors, and administrators shall forever warrant and defend the title to said real estate against all lawful claims and demands whatever.

And I, the said Edith Cone wife of the said L. K. Cone  
for and in consideration of the said sum of money, do hereby release and quit-claim, transfer and relinquish unto the said John W. Overstreet  
guardian aforesaid and his heirs and assigns, all my right or possibility of dower in or to said lands.

The foregoing conveyance is on conditions: That, whereas, the said L. K. Cone  
is justly indebted to the said John W. Overstreet guardian of William Bittle a minor in the sum of  
Two Thousand and no/100 DOLLARS, for borrowed money, evidenced by  
one note for \$2000.00 due Nov 15<sup>th</sup> 1912 bearing 6% interest from date  
secured by ten notes of \$60.00 each due every six months

Now, if the said L. K. Cone shall pay or cause said note to be paid,  
with interest, according to the tenor and effect thereof, then this instrument to be null and void; otherwise to remain in full force and effect.

And it is hereby further stipulated that during the continuance of this instrument in force, the said L. K. Cone  
shall at all times keep all taxes fully paid, as required by law, and shall keep the buildings on said premises insured against loss or damage by fire and tornado in the sum of not less  
than \$2000.00; loss, if any, payable to the said John W. Overstreet guardian of William Bittle a minor as his interest may appear.

And it is further hereby agreed, that in case the said L. K. Cone shall make default in  
payment of taxes or of keeping said building insured as aforesaid, then the said John W. Overstreet guardian  
or his legal representative, may pay such taxes, and effect such insurance, and the amount necessarily expended therefor, with interest at 8 per cent. per annum  
from the date of such expenditure until repaid shall be considered a sum, the repayment of which is intended to be hereby secured. And we hereby waive all rights of appraisalment  
or redemption to which we are entitled under the Acts of the Legislature, approved March 17, 1870, and March 17, 1883, respectively.

And if default be made in payment of the sums hereby secured at maturity, or when the same or either of them becomes due and payable, then the said grantee, or  
his assign, agent or attorney, shall have power to sell said property at public sale, to the highest bidder, for cash, in Tulsa Indian  
Territory public notice of the time and place of said sale having first been given 30 days, by advertising

in some newspaper published in said Tulsa I. T. or by printed or written handbills posted up in ten  
public places in said city; at which sale the said grantee or assignee may bid and purchase as any third person might do; and we hereby authorize the said grantee or assignee to  
convey said property to any one purchasing at the said sale, and the recitals of his deed of conveyance shall be taken as prima facie true, and the proceeds of said sale shall be  
applied, first, to the payment of all costs and expenses attending said sale; second, to the payment of said debt and interest; and the remainder, if any, shall be paid to said grantors.
