Andrew Johnson, as the heirs of Halbutter Micco, and Wydie Bucktrot, widow, Wam Greene Bucktrot, Wysena Bucktrot, Conzie Bucktrot, Agnes Rucktrot, Anges Bucktrot, and Siggie Bucktrot, minor heirs of Bucktrot 1, deceased, for whom, J.A. Fulp is the regular and legally appointed guardian also Lucy Bucktrot, and the defendant, Nannie Littlehead, as the sole surviving heirs of Bucktrot, deceased, conveying thereby all the right, title and interest of said parties in and to said tract of land, described in said decree as the west half (W 1/2) of the west half (W 1/2) of section twenty two (22) township seventeen (17) range thirteen (13) containing one hundred and sixty (160) acres more or less.

It is further ordered, adjudged and decreed by the court that the Clerk of this court be and he is hereby authorized and instructed to pay over and distribute to the parties entitled thereto, as plaintiffs, and defendants, to this action, the distributive and proportionate share of each according to the decree heretofore entered, to the heirs of Bucktrot, deceased, or their assigns, one half of said sum of Twenty one hundred and sixty dollars (\$2160.00) or to Madie Wydie Bucktrot, or her assigns, one hundred and twenty dollars (120.00) the defendant Nannie Littlehead, or her assigns, one hundred and twenty dollars (\$120.00); to Luck Bucktrot, or her assigns one Hundred and twenty dollars (120.00) and to J.A. Fulp as guardian of said minors, Sam Green Bucktrot, Wysena Rucktrot, Conzie Bucktrot, Agnes Bucktrot, Angee Bucktrot, and Siggie Rucktrot, the sum of seven hundred and twenty dollars (\$720.00) or one hundred and twenty dollars (\$120.00) for each minor and to Andrew Johnson, or his assigns, one half of said sum of twenty one hundred and sixty dollars (\$2160.00).

It is further ordered, adjudged and decreed by the court that James J.

Mars, attorney for the minors plaintiffs in this action, is hereby allowed the sum of One Hundred and fifty dollars (\$150.00) for his fee for services rendered on behalf of J.A. Fulp, guardian of said minors, and the Clerk of this Court is authorized to pay to him, said sum out of the funds belonging to said minors, and the balance to be paid to their guardian.

And it funther appearing to the court that the lien upon said land allowed James J. Mars, for his services rendered in this case, on representation made in open court has been fully discharged and satisfied.

It is therefore ordered, adjudged and decreed by the court that said lien be and the same is hereby discharged and fully satisfied.
