The South east Quarter of the South East Quarter of Section Seventeen, Township Eighteen North, Range Fourteen East, containing forty acres more or less according to the government survey and being the homestead allotment of said Eliza Cooper.

TO HAVE AND TO HOLD THE SAME, unto the said party of the first part, from the 1st day of January 1911, to the 1st day of January 1914,
