KNOW YE, That, whereas Daniel W. Tyner has on this day by the United States Court in probate in and for the said Western District in the Indian Territory been appointed guardian for Cordelia W. Tyner minor, under the age of 14 years, by his entering into bond to the United States of America for the use of said minor in the sum of Six hundred and Fifty Dollars, and whereas the said Daniel W. Tyner has this day filed his bond in such sum to the United States of America for the use of said minor, which said Bond stands approved by the court.

NOW THEREFORE, he, the said Daniel W. Tyner hereby authorize and empower to collect and receive all moneys, property, and effects, that are now, or hereafter may become due to his said ward, and in general to do and perform all and singular the duties devolving upon him as such guardian by law, or that may be enjoined upon him by the lawful order, sentence or decree of any Court having competent jurisdiction.
