And the second party further agrees to take care of all improvements now on said premises.

It is also expressly understood and agreed that the said second party shall deliver up possession of said premses with all improvements, except as otherwise agreed in this contract, at the expiration of said term in good condition (natural wear considered) without further notice on the part of the said first party.
