Crosbie, party of the second part, the receipt of which is hereby acknowledged have granted, bargained and sold, and do hereby grant, bargain, sell and convey unto the said second party his heirs or assigns the following described real estate situated in the City of Tulsa, Oklahoma, towit:

That part of Lot 7 in Block 88, more particularly described as commencing at the southwest corner of lot seven in said block 88 and running thence in an easterly direction along the north line of E. 2nd St. 115 feet, thence in a northerly direction parallel with the west line of tetalley, in said Block 88, fifty feet; thence in a westernly direction parallel with the north line of E. 2nd St. a distance of 115 feet to the east line of south Boston Avenue; thence in a southerly direction along the east line of South Beston Avenue a distance of fifty feet to the place of beginning.
