removal of the restrictions upon the alieanation of her allotement (except her homestead), and am, as the resultof that investigation, satisfied that the removal of restrictions upon the alienation of her allotted lands, except as to her homestead, will be for the best interests of the allottee, and I so recommend. The approval of this certificate addes not in any manner determine the right of the allottee to any particular tract of land.
