Now on this 27th day of July, 1910, this matter came on to be heard upon the petition of Thomas E. Brummett praying for an order authorizing the said petitioner to transfer to The Tulsa Coal Mining Company an undivided two thirds interest in and to that certain coal and asphalt mining lease executed by John Bullette as guardian of Floyd C. Bullette, a minor, to the said Thomas E. Brummett, on the 17th day of June, 1908 covering the following described property, to-wit:

The North Half ($\frac{1}{2}$) of the northwest Quarter ($\frac{1}{4}$) of the northwest quarter ($\frac{1}{4}$) and the southwest quarter ($\frac{1}{4}$) of the Northwest quarter ($\frac{1}{4}$) of the Northwest quarter ($\frac{1}{4}$) of Section Thirty four (34) Township Twenty (20) North, range Thirteen (13) East, in Tulsa County, Oklahoma,

the said lease having been approved by this court on the 19th day of June, 1908 and filed for record with the Register of Deeds of Tulsa County, Oklahoma, on the 24th day of June 1908;

And the said Thomas E. Brummett appearing in person and by his attorneys, Wrightsman, Bush & Johnson, and the court having heard the testimony of witnesses herein, the court finds that there was a certain lease for coal and asphalt mining purposes so executed, delivered and approved as above set forth: That The Tulsa Coal Mining Company is a competent and reliable corporation, financially able to prospect and develop the said land for coal and asphalt mining purposes; and the court further finds that it will be to the great advantage of the minor herein that the said Thomas E. Brummett make an assignment of an undivided two thirds interest in and to said lease to the said The Tulsa Coal Mining Company.

Now, Therefore, it is ordered, adjudged and decreed by this court, that the said Thomas E. Brummett be authorized and permitted to make an assignment to The Tulsa Coal Mining Company of an undivided two thirds interest in and to that certain coal and
