ASSIGNMENT OF AN OIL AND GAS LEASE.

KNOW ALL MEN BY THESE PRESENTS:

Whereas, said lessee therein, James K. Jones, is now deceased and the undersigned are the heirs and representatives of said deceased James K. Jones, and are the owners of the said oil and gas lease; and,

WHEREAS, the undersigned have agreed upon the terms and conditions of a sale, transfer and assignment of said oil and gas lease and all right, title and interest therein held and owned by the said lessee and his heirs unto the Argue & Compton Company.
