LAST WILL AND TESTAMENT.

Be it known that I, Sarah R. Stephens, of Claremore, Oklahoma, being of sound mind and lawful age, do make and execute this my last Will and Testament.

1st. I hereby give, bequeath and devise unto my daughter, Mrs. Marcus P. Evans of Lometa, Oklahoma, the following described lands, situated in Tulsa County, state of Oklahoma, to-wit: Lot eight (8) and the North West Quarter of the South east quarter of the South East Quarter of Section Eleven (11), Township Twenty (20), north, Range Twelve (12) East, containing forty and 79/100 (40.79) acres, more or less.

Second. To the balance of my children, to-wit: Ida L. Haworts, Ola S. Carter, Spencer A. Stephens, Earnest L. Stephens, and Mrs Jessie Nelson, I hereby give and bequeath the sum of One Dollar each, respectively, and direct my executor to pay same out of any property that I may die possessed of and which is not otherwise disposed of.

3rd. I hereby appoint my son-in-law, Marcus P. Evans, of Lometa, Oklahoma, my executor of this my lastwill and testament, and direct that he be appointed by the proper court as such executor and that he be allowed to serve as such executor without giving bond.

4th. I hereby declare this to be my last will and testament and that I make and execute the same as my free and voluntary act and deed without undue influence, compulsion or duress of any kind or nature.
