Hamilton as guardian aforesaid, executed to O. K. Eysenbach an oil and gas mining lease on the following described land of said minor, in Tulsa County, Oklahoma, to-wit:

The SE+ of Section 25, Township 18 North, Range 12 East of the Indian Base and meridian.

and that said lease was made subject to conformation by this court, the said lease bearing date of this day, and for the period of 9 years from this date, and as long thereafter as oil or gas is found in paying quantities; and that the said Eysenbach has paid to the said guardian as bonus for said lease the sum of \$250.00 which is a fair and reasonable bonus therefor, and that said lease carries one-eight royalty of all the oil produced thereunder to the lessor and \$150.00 per year for each and every gas well from which the gas is marketed off the premises, and that the provisions and conditions of the said lease are the usual and customary provisions and conditions in oil and gas leases, and are fair and reasonable, and that said lease is regular in form and properly executed; and that the hest interest of the said ward and the said ward's estate are served by the execution of said lease.
