It is agreed that, while the product of each well in which gas only is found shall be marketed from said premises the second party wall pay to the first parties therefor at the rate of One Hundred Fifty (150) Dollars per annum and give the first parties gas for domestic purpses at the d welling house during the same time.

Whenever tirst parties shall request it, second party shall bury all oil and gas lines which are laid over tillable ground, Second party also agrees to pay all damages to crops by reason of laying and removing pipe lines. No well to be nearer that 250 feet of residence buildings expremises.

Second party agrees to commence a well on said premises within ninety (90) days from date.

"All moneys falling due under the terms of this grant may be paid direct to the first parties to the credit of first parties at the First National Bank of Claremore, Oklahoma.

In further consideration for the payment of said sum of One Thousand Dollars first above mentioned, first parties grant unto second party the exclusive option to release and terminate this grant or any undrilled po rtion thereof at any time; thereafter all liabilities of second party as to the portion released shall cease and determine . If oil is found in paying quantities on either tract of 20 acres on which the second party drills, then second party agrees to use reasonably diligence in developing the tract of land drilled on for oil and gas.

Second party shall have the right to use sufficient gas, oil and water to drill all wells and for all purposes necessary or convenient in operating the same.

The terms and conditions of this grant shall extend to the heirs, successors and assigns of the parties hereto.
