same, then this mortgage shall be wholly discharged and void, and other wise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the same due, and if the taxes and assessments of every nature are or may be assessed and levied against said premises or any part thereof are not paid when the same are by law made due and payable, the whole of said sum or sums, and the interest thereon, shall then become due and payable and said party of the second part shall be entitled to possession of said premises. And said parties of the first part for said consideration do hereby expressly waive an appraisment of said real estate and all benefit of the homestead exemption and stay laws of the state of Oklahoma.
