qualified and acting guardian of the estate of said minor.

Your petitioner further states that said minor is 6 yars of age, having been born upon the day October 1904, and is a duly enrolled citizen of the Creek Nation, and that he has had allotted to him and was received as his allotment in the Creek Nation, and now owns in fee simple the following described land, situated in Tulsa County, State of Oklahoma, to-wit: South west quarter of section 25, Township 19 North, Range 11 East, and containing 160 acres, more or less.

your petitioner further states that said land is not cultivated and thereby produces an annual revenue of approximately snone, and he further states that his said ward has no personal property and no money, but that said land abve described constitutes his entire estate.

Petitioner alleges that said lands above described have some indications of having a value for oil and gas purposes, and that he believes that said lands can be leased for oil and gas purposes for a term of during the minority of his said ward and as much longer thereafter as oil and gas is found in paying quantities, and he states that a lease for oil and gas purposes on said land would be to the manifiest interest of his said ward, and that it will, if in fact containing oil and gas, or either produce a revenue that cannot be otherwise produced and that the exploration and development of said land for oil andgas will protect said land from drainage and waste.

Your petitioner alleges that said land should be leased for oil and gas purposes for a cash bonus, and a royalty reserved in said lease. That the proceeds from said lease are necessary for the support, education and maintenance of said ward, and that the surplus, if any obtained from said lease should be put out at interest, or invested in some security or productive stocks, as the court may direct and hereafter order

Your petitioner further states that the said ward resides in Dustin, Hughes County, State of Oklahoma.

Wherefore, your petitioner prays that the court make an order herein authorizing and directing him as such guardian of said ward Raymond Wilson to lease said land for oil and gas purposes during the minority of the said ward and he further prays that in as much as he believes that he could make an advantageous sale of said lease at private sale that he authorized by the court upon a hearing of the facts to lease said lands at private sale.
