ORDER AUTHORIZING SALE OF OIL AND GAS MINING LEASE.

This cause coming on for hearing on tis 13 day of August 1910, the same being a regular day of the July 1910 term of said court in and for Hughes County, upon the petition of the guardian for leave to lease the land of his ward, Raymond Wilson, therein described, and hereinafter described, for oil and gas purposes for a term of years during the minority of his said ward and as much longer thereafter as oil and gas is found in paying quantities, and,

It appearing from said petition and from the evidence that it would be to the manifest interest of his said ward that the said real estate be leased for oil and gas purposes and that the proceeds therefrom be used for the support, education and maintenance of said ward and that the balance, if any, be put out at interest in some productive stocks or securities, as the court may hereafter determine and order and it appearing that it would be to the benefit of the estate to sell said lease at private sale:

It is therefore ordered, adjudged and decreed by the Court that the said guardian sell at private sale as asked for in the petition an oil and gas lease during the minority of his said ward, on the following described land, situated in Tulse County, State of Oklahoma, to-wit: South west quarter of Section 25, Township 19 North Range 11 East, and containing 160 acres, more or less.

It is further ordered that said sale be for **e** cash bonus of not less than \$1.25 per acre, and a royalty of not less than one eighth of all the oil produced and saved from the premises or its equivalent in money at the market value thereof, and the said guardian R. Bean Wilson is hereby ordered and directed to sell on the most advantageous terms, said lease for oil and gas purposes for a term during the minority of his said ward and as much longer thereafter as oil and gas is found in paying quantities at private sale.

It is therefore ordered that the said guardian receive bids and offers on the said lease from whomsoever may approach him and offer to buy the same, and said guardian will return and report his his actions to this court.
