ORDER CONFIRMING SALE OF OIL AND GAS MINING LEASE.

THIS CAUSE COMING ON FOR FINAL HEARING BEFORE THIS court on this 13th day of August, 1910, the same being a regular day of the July 1910, term of said court, on the return of the guardian R. Bean Wilson, and the report of his proceedings under the order of sale heretofore made, and it having been proven that in pursuance of the said order of sale as ordered by this court the said guardian sold at private sale to S.S. Owen an oil and gas mining lease on the land of his said ward, situated in Tulsa County State of Oklahoma, to-wit:

South west quarter of Section 25, Township 19 North, Range 11 East, and containing _____ acres, more or less, during the minority of said ward, and it appearing to the court that the said purchaser S.S. Owen has paid a cash bonus of \$1.25 per acre or a total of \$2.00.⁰⁰ to the said R. Bean Wilson, as Guardian, and it appearing that the said S.S. Owen is the highest and best bidder for said lease, and that the sale was made and conducted fairly and legally and in accordance with the order of this court, and it further appearing that the said bid of S.S. Owen, to-wit the sum of \$200.00 and a royalty of One eighth of all the oil produced and saved from the premises, or its equivalent in money, and the sum of \$150.00 per year for each gas well from which gas is marketed is fair and adequate and is not disproportionate to the value of said oil and gas lease, and that a greater sum cannot be obtained.

It is therefore ordered and adjudged by the Court that the said sale of the said oil and gas lease to the said S.S. Owen be confirmed and approved, and it is ordered that the said guardian R. Bean Wilson execute to the said purchaser S.S. Owen an oil and gas mining lease and make return to this court for final action and approval.
