## MORTGAGE

WHEREAS, the said parties of the first and second parts have applied to the said parties of the third part for aid to enable the parties of the first and second parts to erect or possess a House of Worship adapted to their wants; and, Whereas, the said parties of the third part have granted such aid to the amount of Two Hundred dollars and, Whereas, the said party of the first part has voted to apply for and receive said gift, on the terms and conditions contained in this mortgage and has authorized the said parties of the second part to make, execute and deliver this mortgage to the said parties of the third part.
