Whereas, Emma Drew and C.C. Drew have this 6th day of July, 1910, been absolutely divorced by the decree of the District Court of Tulsa County, State of Oklahoma, and

Whereas, it is recited in said decree that all matters of property between them have been settled outside of Court, and in consummation of said recital and as evidence thereof, this indenture witnesseth,

That we hereby release, relinquish, and convey one to the other absolutely all our respective interests, right and title of whatsoever nature in and to the respective tracts of real estate herein-named, this being intended as mutual conveyances in one, and being as well an absolute partition of all our real estate, belonging to us, to our knowledge and belief; and as a final adjustment of all our claims and differences concerning real estate, and this to be taken and deemed as contemporaneous with said decree of divorce, that is to say;

C.C. Drew hereby relinquishes all right and claim and hereby conveys title to the following described real estate to Emma Drew;

N $\frac{1}{2}$ of NE $\frac{1}{4}$, (E 30 acres of SE $\frac{1}{4}$ of NE $\frac{1}{4}$), NW $\frac{1}{4}$ of NW $\frac{1}{4}$, all in Sec. 19; also E $\frac{1}{2}$ of NW $\frac{1}{4}$. S. 10 acres of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 20, all in Twp. 19, N.R. 13 E.

W $\frac{1}{2}$ of W $\frac{1}{2}$ of NE $\frac{1}{4}$ of SE $\frac{1}{4}$, and all of the west fractional one half of the SE $\frac{1}{4}$ of Sec. 36, Twp. 19 N.R. 12 E.

W 50 feet of Lots 10, 11 and 12, block 6, Lindsay Addition to the City of Tulsa.

N 40 feet of Lot 9, and S 25 feet of Lot 10, Block 5, of the Harner Addition to the City of Tulsa.

Also a tract of land described as follows: Commencing at a point 157 feet west and 50 feet north of the south east corner of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 12, Twp. 19 N.
