Thos. F. Crosby, of lawful age, after being duly sworn on his oath states:

That he is a member of the law firm of Crosby & Crosby of Muskogee, Oklahoma. That said firm entered into a written contract with Buelah Morrison on the 8th day of April 1910 and agreed to represent her in a certain Divorce case then pending in Superior Court of Muskogee County wherein Henry Morrison was Defendant.

Said firm was to receive as a fee for said services a one-half interest in any lands or monies that might be allowed Plaintiff as alimony by the Court. "Lien claim" was indorsed on pleadings and a Decree was signed By Judge McCain on June 4th, 1910 allowing and setting aside the west 1/2 of Southwest 1/4 of Section 31 of Township 19 North and Range 14 East, being 80 acres of surplus allotment of said Henry Morrison, as permanent alimony of said Plaintiff.
