Perryman, a minor by The Gulf Pipe Line Company of Oklahoma, the receipt whereof is hereby acknowledged I do hereby grant and convey unto said Gulf Pipe Line Company of Oklahoma, its successors and assigns, the right to locate, maintain and operate a pipe line for the purpose of conveyance of oil over, through and upon that certain tract of land situated in Tulsa County and thus described NW# of section 35, township 18 north, range 12 east, being 160 rods: Rachel Foryman AllHumd.

The rights herein granted shall permit the use of such land as may be necessary for said pipe line fand shall also permit the grantee herein, its successors and assigns, to do whatever may be necessary to their construction or for the enjoyment of the rights herein granted, including the right of ingress and egress to and from said tract of land for the purpose of laying, maintaining, repairing and restoring of said pipe line, and for removing of same when desired by the grantee its successors and assigns.
