COMPARIO consideration of Eight & co/100 dollars this day paid to Owen Harworth Guardian of Perry E. Harworth, by The gulf Pipe Line Company of Oklahoma, the receipt whereof is hereby acknowledged do hereby grant, and convey unto said gulf Pipe Line Company of Oklahoma, its successors and assigns, the right of way to locate, maintain and operate a pipe line for the purpose of coveyance of oil over, through and upon certain tract of land situated in Tulsa County, Oklahoma, and thus described: The north half of the northwest quarter of section 13, township 20 north, range 12 east 80 rods.

Also there is hereby granted a right to erect and maintain a telephone and telegraph line. The rights herein granted shall permit the use of such land as may be necessary for said pipe line for said telegraph and telephone line, and shall also permit the grantee herein its successors and assigns, to 60 whatever may be necessary to their construction or for the enjoyment of the rights herein granted, including the right of ingress and egress to and from said tract of land for the purpose of laying, maintaining, Aepairing and restoring of said pipe line and said telegraph and telephone line, and for removing of same when desired by the grantee, its successors and assigns. It is understood that the person securing this right of way for said company is without authority to make any agreement, covenant or promise in its behalf not herein specifically shown, and this instrument is delivered and accepted upon the distinct understanding that the consideration herein above #tated is the sole consideration and inducement therefor.
