(Eliza Caudry Allotment) by The Gulf Pipe Line Company of Oklahoma, the receipt whereof is hereby acknowledged of the reby grant and convey unto said Gulf Pipe Line Company of Oklahoma, its successors and assigns, the right to locate, maintain and operate a pipe line for the purpose of conveyance of oil over, through and upon that certain tract of land situted in Tulsa County, Oklahoma, and thus described. The south west quarter of the southwest quarter of section 1 Township 20 north, range 12 east; being 80 rods. along webine line most.

Also there is hereby granted a right to erect and maintain a telephone and telegraph line. It is undratood that the person securing this right of way for said company is without authority to make any agreement, covenant or promise in its behalf not herein specifically shown, and this instrument is delivered and accepted upon the distinct understanding that the consideration herein above stated is the sole consideration and inducement therefor.
