COMPARED In consideration of Eight & co/100 dollars, this day paid to Osage Okla Company by The Gulf Pipe Line Company of Oklahoma, the receipt whereof is hereby acknowledged, I do hereby grant and convey unto said Gulf Pipe Line Company of Oklahoma, its successors and assigns, the right to locate, maintain and operate a pipe line for the purpose of conveyance of oil over, through and upon that certain tract of land. situated in Tulsa County, Oklahoma and thus described Swi of Swi of sec 2 twp. 19 north, range 12 east, being 80 rods:

Also there is hereby granted, a right to erect and maintain a telephone and telegraph line. The rights herein granted shall permit the use of suchland as may be necessary for said pipe line for said tipe line for said telegraph and telephone line, and shall also permit the grantee herein, its successors and assigns, to do whatever may be necessary to their construction or for the enjoyment of the rights herein granted, including the right of ingress and egress to and from said tract of land for the purpose of laying, maintaining repairing and restoring of said pipe line and said telegraph and telephone line, and for removing of same when desired by the grantee, its successors and assigns.
