COMPARED RIGHT OF WAY AGREEMENT

FOR AND IN CONSIDERATION OF THE SUM OF EIGHT No/100 (\$8.00) no/100 dollars to the undersigned owners in hand paid by Gulf Pipe Line Company of Oklahoma, a corporation, the receipt of which is hereby acknowledged, Rosa Chisholm, Spybuck do hereby grant, to the said Gulf Pipe Line Company, a corporation, its successors or assigns, the right of way to lay, maintain, operate, relay and remove a pipe line for the transportation of oil or gas, and erect, maintain and operate a telegraph or telephone line, with right of ingress and egress to and from the same, said right of way being more fully described by plats of definite location, approved by the Secretary of the Interior, on, over and through certain lands allotted to Rosa Chisholf Spybuck a citizen of the Cherokee Nation, Roll No. --- situate in the County of Tulsa, and state of Oklahoma, and described as follows.

South half of north west quarter sec 13, Town 21 North range 12 E being 80 rods.

The said granters, their heirs or assigns, are to fully use and enjoy the said premises except the easem ent for the purposes hereinhefore granted to the said Gulf Pipe Line Company of Oklahoma, a corporation, its successors or assigns.

The said Gulf Pipe Line company of Oklahoma, a corporation, for itself and its successors or assigns, hereby covenants to hury its lines of pipe so that the same will not interfere with the cultivation of said premises.

It is hereby further agreed that the said Gulf Pipe Line Company of Oklahoma, its successors or assigns, may at any time lay additional lines of pipe alongside of the first line, as herein provided for, upon payment of all additional damages and subject to the same conditions, provided assent and approval of the Secretary of the Interior be had therefor, if within the jurisdiction of such Secretary at that time.
