# COMPARED

## MORTGAGE.

This instrument made and entered into this 1st day of July, 1910, by and between D.D. Wertzberger, of Tulsa, Oklahoma, party of the first part and C.W. Suppes party of the second part, witnesseth: That:

Whereas, the first party and the second party are engaged in the business of contracting for and building oil well rigs and derricks in the oil fields in the vicinity of Tulsa, Sapulpa and Okmulgee, Oklahoma, and of purchasing and using in said business all necessary materials and furnishings and equipments for the carrying on of said business, under the firm name and style of Suppes & Wertzberger; and,

Whereas, the first party acquired his interest in said business by purchasing from the second party and undivided half interest in the same business conducted and carried on by the second party prior to the formation of said partnership, whereby the first-party became and is now the owner of an undivided half interest in all the hereinafter described property, and

Whereas, the first party is indebted to the second party in the sum of Two Thousand & Sixteen & 57/100 (\$2016.57) Dollars on the purchase price of said undivided half interest, due and payable as follows: \$500.00 in four months from this date, \$500.00 in eight months from this date, Five hundred dollars in twelve months from this date, and \$516.57 in Sixteen months from this date, with interest thereon at the rate of eight per cent per annum from the date until paid, as is evidenced by four promissory notes of even date herewith, one for \$500.00 due four months from this date; one for \$500.00 due eight months from this date; one for \$500.00 due twelve months from this date and one for \$516.57 due sixteen months from this date, all bearing interest at the rate of eight per cent per annum from this date until paid, this day executed and delivered by the first party to the second party; and

Whereas, the first party and the second party under the firm name of Suppes & Wertzberger are now and shall hereafter, in accordance with partnership agreement, conduct the aforesaid business in the aforesaid localities, and shall from time to time replenish the present stock of material, furnishings appliances and equipment used and employed in said business, and add new materials equipments and appliances thereto from time to time; and

Whereas the first party has agreed to secure the second party in the full and just payment of all the aforesaid indebtedness, together with all the interest and any cost that may accrue thereon by a mortgage on the first party's undivided half interest in all the hereinafter described property, and all other materials, appliances and equipment that
