

OIL AND GAS LEASE

THIS AGREEMENT, Made this 15 day of January A.D. 1912, by and betweenIsaac Newton Phillips and wife of the first part, and  
A. Miller Hammett and J. D. Gillespie of the second part,

WITNESSETH, That the said party of the first part, for One Dollar and other good and valuable considerations, the receipt of which is hereby acknowledged, and in further consideration of the rents, covenants and agreements hereinafter mentioned, has granted, demised and let unto the party of second part, their heirs, successors and assigns, all the oil and gas in and under that certain tract of land hereinafter described, and also all the said tract of land for the purpose and with the exclusive right of drilling and operating for said oil and gas, which said tract of land is situated in Tulsa County, Oklahoma, and described as follows, to-wit:

containing 40 acres, more or less. But no wells shall be drilled within 250 feet of the present buildings, except by mutual consent.

The party of the first part grants the further privilege to the party of the second part, their heirs, successors and assigns, of using sufficient water and gas from the premises necessary to the operations thereon, and all rights and privileges necessary or convenient for conducting said operations and the transportation of oil and gas, and the right to remove at any time machinery or fixtures placed on the premises by said second party.

TO HAVE AND TO HOLD THE SAME unto the said party of the second part, their heirs, successors and assigns, for the term of ten years from the date hereof, and as long thereafter as oil or gas is being produced therefrom by said second party.

IN CONSIDERATION WHEREOF, The said parties of the second part agree to deliver to parties of the first part in tanks or pipe lines the One-eighth (1/8) part of all oil produced and saved from the leased premises. And should gas be found on said premises in paying quantities, second parties agree to pay 15.00 yearly for the products of each gas well, while the same is being sold off the premises, and first party shall have free use of gas for domestic purposes, by making their own connections for such gas at the well at their own risk and expense.

Second parties agree to locate all wells so as to interfere as little as possible with the cultivated portions of the premises and to pay all damages to growing crops caused by said operations.

PROVIDED, HOWEVER, That if a well is not commenced on said premises within one year from date hereof, then this lease and agreement shall be null and void, unless the parties of the second part within each and every year after the expirations of the time above mentioned for the commencement of a well, shall pay a rental of One Dollar per acre until a well is commenced thereon, or until this lease is cancelled as hereinafter provided

And it is agreed that the completion of a well shall be and operate as a full liquidation of all rental under this provision during the remainder of this lease.

All rentals and other payments may be made direct to parties of the first part or may be deposited to their credit at The First Nat. Bk. And further, upon the payment of One Dollar at any time after one year by the parties of the second part, their heirs, successors and assigns, to the parties of the first part, their heirs, successors and assigns, said lessee shall have the right to surrender this lease for cancellation, after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine, and this lease become absolutely null and void

All the conditions between the parties hereto shall extend and apply to their heirs, successors and assigns.
