

THIS INDENTURE, Made and entered into this 23rd day of May, 1912, by and between

Rachel E. Brady and W. T. Brady

WITNESSETH: That whereas, the part of the first part is the owner of the following described property and premises and encumbrances, located in Tulsa County, State of Oklahoma to-wit:

NOW, THEREFORE, As security for the payment of One promissory note, hereinafter described, the party of the first part does by these presents mortgage unto party of the second part, its successors and assigns, the above described oil and gas mining lease and leasehold estate, and all right, title and interest and estate of said first party in and to all and singular the tenements, hereditaments and appurtenances thereunto acquired, belonging, or in anywise appertaining, including all oil stored on said land belonging to first party, and all oil and gas wells, oil well supplies and machinery of every kind and character, buildings, derricks, pipe lines, tanks, casings, telephone lines, live stock, vehicles located on, in or under said above described property, and all other property of every kind and description belonging to said oil and gas well and equipment and leasehold estate, wherever located.

As further security for the payment of said note, the first party assigns to second party the whole part of all oil or gas produced and saved from said premises, during the life of this mortgage; first party hereby agreeing, on demand of second party, to immediately execute all papers and instruments, including those required under pipe-line regulations, necessary to transfer said part of oil or gas to said second party, the proceeds of which are to be applied on the payment of the note, hereinafter mentioned until the same is paid in full, as a further security for the mortgage, and said note part of the first part has mortgaged and hereby mortgages to the party of the second part the above described land
 This mortgage is given as security for the payment of the following described note, executed and delivered by Rachel E. Brady, W. T. Brady

to The Exchange National Bank, of Tulsa, Oklahoma, as joint and several principals and payable to the order of said The Exchange National Bank, of Tulsa, at its offices in Tulsa, Oklahoma, without grace, and with interest at the rate of less per cent. per annum from maturity until fully paid, to-wit:

The conditions of this agreement are as follows: The first party herein covenants and agrees:

FIRST. That it will pay said note, and each of them at maturity, with interest thereon when due. for oil and gas mining purposes
 SECOND. That it will not sell, mortgage, assign or otherwise dispose of any property above described, and will not suffer or permit any part of the same to become subject to any lien, of any kind whatsoever, until this mortgage is fully satisfied, and will not remove, or permit any part of said property to be removed out of the said Tulsa County while this mortgage remains a valid lien for any sum thereon.

THIRD. That it will, in the event said note, herein described are not paid at maturity, or interest paid when due, or in the event any of the covenants expressed in the second condition above set out are violated or broken in any manner, that first party, upon written notice served upon it or any of its agents or employees, will immediately execute all papers and instruments, including all oil and gas wells, oil well supplies and machinery of every kind and character, buildings, derricks, pipe lines, tanks, casings, telephone lines, live stock, vehicles located on, in or under said above described property, and all other property therein described, to second party, or any person or company second party may designate.

The parties hereto mutually understand, and first party covenants and agrees, that in the event first party violates, breaks or fails to perform any of the above covenants or conditions, or any part thereof, or in the event second party deems itself insecure under said mortgage, the said second party herein shall be, and it is hereby authorized, at its option, without notice, to declare all of the said indebtedness due and payable, and to take any one or more of the following methods to enforce its lien, including therein the recovery of all costs, expenses, and reasonable attorney fees incurred in the satisfaction of said debt: Second party may take possession of said oil and gas mining lease and leasehold estate, and all property herein described, and maintain, operate and control the said property, and apply all proceeds derived therefrom on the payment of said note, until the obligations herein are fully paid, first party agreeing to give the second party immediate peaceable possession; or, the second party may take possession of and sell all of said property and interests herein described, under the laws of the State of Oklahoma applicable to foreclosure of mortgages; or, second party, at its option, is hereby authorized to apply for and have appointed a receiver of all the property and interests above described. The first party hereby waives all notice of the appointment of a receiver herein, and agrees not to protest or contest, directly or indirectly, the application for, or the appointment of, a receiver herein, and agrees that a receiver, at the option of second party, may hold, maintain and operate said property, including the running and selling of all oil and gas produced therefrom, and apply the proceeds of the sale thereof to the payment of said note, until said indebtedness is fully paid, or sell and dispose of said property according to law. for the payment of said note and interest

All the terms, conditions and covenants herein shall extend to and bind all the parties herein, their successors and assigns their heirs, executors and administrators
