

COMPARED

AGREEMENT, Made and entered into the 25<sup>th</sup> day of July A. D. 1912., by and between  
 Fannie L. Keys "Single"  
 of Helling, Okla., part y of the first part, lessor, and Jesse Oil Company  
 a corporation, of Tulsa, Okla., part y of the second part, lessee.

WITNESSETH, That the said part y of the first part, for and in consideration of the sum of Eighty <sup>100</sup>/<sub>100</sub> Dollars, in hand well and truly paid by the said part y of the second part, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of the part y of the second part, to be paid, kept and performed, has granted, demised, leased and let, and by these presents do grant, demise, lease and let unto the said part y of the second part, its heirs, executors, administrators, successors and assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines, constructing tanks, buildings and other structures thereon to take care of said products, all that certain tract of land situate in the County of Tulsa, State of Oklahoma, described as follows, to-wit:

The North half of the southwest quarter of Section 24, Township 20 N., Range 13 E., and containing 6.0 acres, more or less.

It is agreed that this lease shall remain in force for the term of ten years from this date, and as long thereafter as oil or gas or either of them is produced therefrom by the part y of the second part, its heirs, executors, administrators, successors and assigns.

In consideration of the premises the said part y of the second part covenants and agrees:

1st. To deliver to the credit of the first part y, its heirs, executors, administrators, successors and assigns, free of cost, in the pipe line to which it may connect, its wells, the equal one eighth part of all oil produced and saved from the leased premises.

2nd. To pay to first part y one hundred <sup>100</sup>/<sub>100</sub> Dollars each year in advance for the gas from each well where gas only is found, while the same is being used off the premises, and the first part y to have gas free of cost to heat 2 stoves in dwelling house on said premises during the same time.

3rd. To pay to first part y for gas produced from any oil well and used off the premises at the rate of <sup>100</sup>/<sub>100</sub> Dollars per year for the time during which such gas shall be so used, said payments to be made each three months in advance.

The part y of the second part agrees to complete a well on said premises within 12 months from the date hereof, or pay at the rate of Eighty <sup>100</sup>/<sub>100</sub> Dollars, in advance, for each additional 12 months such completion is delayed from the time above mentioned for the completion of such well until a well is completed, and it is agreed that the completion of such well shall be and operate as a full liquidation of all rent under this provision during the remainder of the term of this lease.

The part y of the second part shall have the right to use gas, oil and water from wells, springs or streams produced on said land for its operation thereon, except water from wells of first part y.

When requested by first part y, the second part y shall bury its pipe lines below plough depth on cultivated land.

No well shall be drilled nearer than 300 feet to the house or barn on said premises.

Second party shall pay for damages caused by it to growing crops on said lands.

The part y of the second part shall have the right at any time to remove all machinery and fixtures placed on said premises, including the right to draw and remove casing. All payments which may fall due under this lease may be made direct to Fannie L. Keys or deposited to her credit in First National Bank, Tahlequah, Okla.

The part y of the second part, its heirs, executors, administrators, successors and assigns, shall have the right at any time on payment of One <sup>100</sup>/<sub>100</sub> Dollars to part y of the first part, her heirs, executors, administrators and assigns, to surrender this lease for cancellation, after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine.

All covenants and agreements herein set forth between the parties hereto shall extend to their heirs, executors, administrators, successors and assigns.
