

COMPARED AGREEMENT, Made and entered into the 12th day of February A. D. 1910, by and between Andy Prince Guardian of Rosella Lewis a minor, party of the first part, lessor, and S. D. Felt a corporation, of the second part, lessee.

WITNESSETH, That the said part of the first part, for and in consideration of the sum of eighty Dollars, in hand well and truly paid by the said part of the second part, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of the part of the second part, to be paid, kept and performed, have granted, demised, leased and let, and by these presents do grant, demise, lease and let unto the said part of the second part, their heirs, executors, administrators, successors and assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines, constructing tanks, buildings and other structures thereon to take care of said products, all that certain tract of land situate in the County of Tulsa, State of Oklahoma, described as follows, to-wit: Southeast quarter of southeast quarter of northeast quarter of northeast quarter of Section 20, Township 19N, Range 10E, and containing 160 acres, more or less.

It is agreed that this lease shall remain in force for the term of 10 years from this date, and as long thereafter as oil or gas or either of them is produced therefrom by the part of the second part, their heirs, executors, administrators, successors and assigns.

In consideration of the premises the said part of the second part covenants and agrees: 1st. To deliver to the credit of the first part, their heirs, executors, administrators, successors and assigns, free of cost, in the pipe line to which may connect the wells, the equal one-eighth part of all oil produced and saved from the leased premises. 2nd. To pay to first part one hundred fifty Dollars each year in advance for the gas from each well where gas only is found, while the same is being used off the premises, and the first part to have gas free of cost to heat and use in dwelling house on said premises during the same time. 3rd. To pay to first part for gas produced from any oil well and used off the premises at the rate of one dollar per year for the time during which such gas shall be so used, said payments to be made each three months in advance.

The part of the second part agrees to complete a well on said premises within one year from the date hereof, or pay at the rate of eighty Dollars, in advance, for each additional 12 months such completion is delayed from the time above mentioned for the completion of such well until a well is completed, and it is agreed that the completion of such well shall be and operate as a full liquidation of all rent under this provision during the remainder of the term of this lease.

The part of the second part shall have the right to use gas, oil and water from wells, springs or streams produced on said land for its operation thereon, except water from wells of first part.

When requested by first part, the second part shall bury its pipe lines below plough depth on cultivated land. No well shall be drilled nearer than one mile feet to the house or barn on said premises. Second party shall pay for damages caused by it to growing crops on said lands.

The part of the second part shall have the right at any time to remove all machinery and fixtures placed on said premises, including the right to draw and remove casing. All payments which may fall due under this lease may be made direct to Andy Prince, Guardian or deposited to the credit in the Court of Oklahoma, said party of the second part, agree to off set all wells drilled with 300 feet of said land.

The part of the second part, their heirs, executors, administrators, successors and assigns, shall have the right at any time on payment of Dollars to party of the first part, their heirs, executors, administrators and assigns, to surrender this lease for cancellation, after which all payments and liabilities thereunder to accrue under and by virtue of its terms shall cease and determine.

All covenants and agreements herein set forth between the parties hereto shall extend to their heirs, executors, administrators, successors and assigns. WITNESS our hands and seals, the day and year above set forth.
