

## OIL AND GAS LEASE.

AGREEMENT, Made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 191\_\_\_\_, by and between \_\_\_\_\_ of \_\_\_\_\_ Oklahoma, part \_\_\_\_\_ of the first part, and \_\_\_\_\_ of \_\_\_\_\_ part \_\_\_\_\_ of the second part,

WITNESSETH: That the said part \_\_\_\_\_ of the first part, for and in consideration of the sum of \_\_\_\_\_ Dollar \_\_\_\_\_ in hand well and truly paid, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of the said part \_\_\_\_\_ of the second part, to be paid, kept and performed, ha \_\_\_\_\_ granted, demised, leased and let, and by these presents do \_\_\_\_\_ grant, demise, lease and let unto the said part \_\_\_\_\_ of the second part, \_\_\_\_\_ heirs or assigns, for the sole and only purpose of operating for and producing oil and gas, and of laying pipe lines, and of building tanks, stations and structures thereon to take care of the said products, with the right of going in, upon, over and across said land for the purpose of operating the same, all of the following described land, situated in \_\_\_\_\_ County, State of Oklahoma, to-wit:

Section \_\_\_\_\_ Township \_\_\_\_\_ North, Range \_\_\_\_\_ East, containing \_\_\_\_\_ acres, more or less, and being the same land which was allotted to \_\_\_\_\_

IT IS AGREED, That this lease shall remain in force for the term of Five Years from this date, and as long thereafter as oil or gas, or either of them, is produced therefrom by the part \_\_\_\_\_ of the second part, \_\_\_\_\_ heirs or assigns.

IN CONSIDERATION OF THE PREMISES, The said part \_\_\_\_\_ of the second part covenant \_\_\_\_\_ and agree \_\_\_\_\_: 1st—To deliver to the credit of the said first part \_\_\_\_\_ heirs or assigns, free of cost, in the pipe line to which \_\_\_\_\_ may connect \_\_\_\_\_ wells, the equal \_\_\_\_\_ part of all oil produced and saved from the leased premises; and, 2nd—To pay to said first part \_\_\_\_\_ heirs or assigns \_\_\_\_\_ Dollars per year for the gas from each and every gas well drilled on said premises, the product from which is marketed and sold off the premises, said payment to be made on each well within sixty days after commencing to use the gas therefrom, as aforesaid, and to be paid yearly, in advance, thereafter while the gas from said well is so used. The part \_\_\_\_\_ of the first part shall have the privilege of using at \_\_\_\_\_ own risk, free of cost, sufficient gas for one dwelling house from any gas well found on above described land by making \_\_\_\_\_ own connection at the well. First part \_\_\_\_\_ to fully use and enjoy said premises for farming purposes, except such parts as may be used by second part \_\_\_\_\_ in operating upon said premises.

IT IS FURTHER AGREED, That a well shall be completed upon the above described premises within one year from the date hereof, and in case a well is not completed as above provided the part \_\_\_\_\_ of the second part shall pay to the part \_\_\_\_\_ of the first part, \_\_\_\_\_ heirs or assigns, an annual rental of \_\_\_\_\_ Dollars, in advance, for each year such completion is delayed until a well is completed; and it is agreed that the completion of a well shall be and operate as a full liquidation of all rental under this lease during the remainder of the term. All payments may be made direct to the lessor \_\_\_\_\_ or deposited to \_\_\_\_\_ credit in the \_\_\_\_\_ Bank of \_\_\_\_\_.

IT IS AGREED, That the second part \_\_\_\_\_ shall have the privilege of using sufficient water, oil and gas from the premises to run all necessary machinery, and at any time may remove all machinery and fixtures placed on said premises; and, further, upon the payment of \_\_\_\_\_ Dollars, at any time, or by a deposit of said sum, together with all amounts due hereunder, in the \_\_\_\_\_ Bank of \_\_\_\_\_ aforesaid, said part \_\_\_\_\_ of the second part, \_\_\_\_\_ heirs or assigns, shall have the right to surrender this lease for cancellation, and the delivery of a release to first part \_\_\_\_\_ in person or the deposit of the same together with the money in the \_\_\_\_\_ Bank aforesaid, shall operate as a complete surrender of all interest in said property, after which all payments and liabilities shall cease and determine and this lease become absolutely null and void.
