## WARRANTY DEED

COMPARED

KNOW ALL MEN BY THESE PRESENTS, That

the following-described real property and premises, situate in Tulsa County, State of Oklahoma, to-wit:*

An undivided one-twenty-fourth ( $\frac{1}{24}$ ) interest in a certain tract of land, described as follows, beginning at the Northwest corner of Section 29, Township 21 North, Range 13 East, thence running Eleven (11) chains South, thence running ten (10) chains East, thence running Eleven (11) chains North, thence running ten (10) chains West, to point of beginning containing Eleven (11) acres, more or less, same being part of the allotment of Carrie Rogan (enrolled as Carrie Toney) a Cherokee Citizen of the One-sixteenth Blood, and whose roll number is 30305.

also including all of the water rights thereto
