GUARDIAN'S DEED

THIS INDENTURE, Made the 17th day of February Nineteen Hundred and Eleven at Stilwell, Adair County, State of Oklahoma, by and between John W. Ferguson the duly appointed, qualified and acting Guardian of Mary Saunders, a minor of Stilwell, Oklahoma party of the first part, and J. D. Ward of Collinsville, Oklahoma the part of of the second part:

WITNESSETH, That, whereas, on the 16th day of January 1911, the County Court, within and for the County of Adair, State of Oklahoma, made an Order of Sale, authorizing the said party of the first part to sell certain real estate of the said Mary Saunders, a minor situated in the County of Tulsa State of Oklahoma, described in said order of sale,

And, whereas, under and by virtue of said Order of Sale, and pursuant to legal notices given thereof, the said party of the first part, on the 4th day of February A. D. Nineteen Hundred and Eleven sold the hereinafter described real estate specified and described in said Order of Sale, subject to confirmation by said Court, for the sum of One thousand & no cents DOLLARS, to J. D. Ward being the highest and best bidder, and that being the highest and best sum bid.

And, whereas, the said County Court, upon the due and legal return of his proceedings under the said Order of Sale, made by the said party of the first part on the 4th day of February A. D. 1911,

did on the 16th day of February 1911, make an order confirming said sale, and directing conveyances to be executed to the said part of of the second part; a certified copy of which order of confirmation was recorded in the office of the Register of Deeds of said Tulsa County, within which the said land sold is situated, on the 16th day of February A. D. 1911, in Book 22 on page 610, and which said order of confirmation now on file and of record in said County Court, and which said record thereof in said Register of Deeds' office, are hereby referred to and made a part of this indenture.

Now, therefore, the said John W. Ferguson as the Guardian of the said Mary Saunders, a minor as aforesaid, the party of the first part, pursuant to the order last aforesaid of the said County Court, and for and in consideration of the sum of One thousand & no cents DOLLARS, to him in hand paid by the said part of of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said part of of the second part, his heirs and assigns, forever, all the right, title, interest and estate of the said Mary Saunders, a minor

in and to all the certain lot, piece or parcel of land, situated, lying and being in said County of Tulsa State of Oklahoma, and bounded and particularly described as follows, to-wit:
The North East Quarter of the South East Quarter and the North West Quarter of the South East Quarter of the South East Quarter of Section Eleven (11) Township Twenty-two (22) North and Range Thirteen (13) East containing 50 acres more or less in Tulsa County, Oklahoma.

together with the tenements, hereditaments and appurtenances whatsoever to the same belonging or in anywise appertaining.

TO HAVE AND TO HOLD, All and singular, the above-mentioned and described premises, unto the said part of of the second part, his heirs and assigns, forever.
