## GUARDIAN'S DEED

THIS INDENTURE, Made the 3rd day of April Nineteen Hundred and Eleven  
at Tulsa, Cherokee County, State of Oklahoma, by and between James R. Garris  
the duly appointed, qualified and acting Guardian of Mable A. Garris a minor

WITNESSETH, That, whereas, on the 7th day of January 1911, the County Court,  
within and for the County of Cherokee, State of Oklahoma, made an Order of Sale, authorizing the said party  
of the first part to sell certain real estate of the said Mable A. Garris a minor  
situated in the County of Tulsa, State of Oklahoma, described in said order of sale,

And, whereas, under and by virtue of said Order of Sale, and pursuant to legal notices given thereof, the said party of the first part, on  
the 6th day of February A. D. Nineteen Hundred and Eleven sold the hereinafter  
described real estate specified and described in said Order of Sale, subject to confirmation by said Court, for the sum of

And, whereas, the said County Court, upon the due and legal return of Guardian's proceedings under the said Order  
of Sale, made by the said party of the first part on the 6th day of February 1911,  
did on the 6th day of March 1911, make an order confirming said sale, and directing conveyances  
to be executed to the said part Y of the second part; a certified copy of which order of confirmation was recorded in the office of the Register  
of Deeds of said Tulsa County, within which the said land sold is situated, on the 1st day  
of April A. D. 1911, in Book 161 on page 484, and which said order of confirmation now  
on file and of record in said County Court, and which said record thereof in said Register of Deeds' office, are hereby referred to and made a part  
of this indenture.

Now, therefore, the said James R. Garris  
as the Guardian of the said Mable A. Garris a minor

as aforesaid, the party of the first part, pursuant to the order last aforesaid of the said County Court, and for and in consideration of the sum of  
seven thousand three hundred DOLLARS,

to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has  
granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said part Y of the second part,  
his heirs and assigns, forever, all the right, title, interest and estate of the said  
Mable A. Garris a minor

in and to all the certain lot, piece or parcel of land, situated, lying and being in said County of Tulsa  
State of Oklahoma, and bounded and particularly described as follows, to-wit:  
The south half of the north-west quarter Sec 6, 34 acres of right of way  
of St. L. & S. F. R.R. of section 32, Township 20 north, Range 15 East  
Containing 73.66 more or less

together with the tenements, hereditaments and appurtenances whatsoever to the same belonging or in anywise appertaining.

his heirs and assigns, forever.
