GUARDIAN'S DEED

THIS INDENTURE, Made the 22nd day of July, Nineteen Hundred and eleven
at Wagoner State of Oklahoma, by and between James H. Kennedy
the duly appointed, qualified and acting Guardian of

Charley Cowans, a minor,
T. C. Herrill of Wagoner, Oklahoma party of the first part, and
the part Y of the second part:

WITNESSETH, That, whereas, on the 29th day of April, 1911, the County Court,
within and for the County of Wagoner, State of Oklahoma, made an Order of Sale, authorizing the said party
of the first part to sell certain real estate of the said Charley Cowans, a minor,
situated in the County of Tulsa State of Oklahoma, described in said order of sale, as 3 1/2 of
N E 1/4 of section 13, Township 19 North, Range 10 East,

And, whereas, under and by virtue of said Order of Sale, and pursuant to legal notices given thereof, the said party of the first part, on
the 26th day of June, A. D. Nineteen Hundred and eleven sold the hereinafter
described real estate specified and described in said Order of Sale, subject to confirmation by said Court, for the sum of
Two Hundred Sixty-two and 50/100 DOLLARS,
to T. C. Herrill he being the highest and best bidder, and that being the highest and best sum bid.

And, whereas, the said County Court, upon the due and legal return of said guardian's proceedings under the said Order
of Sale, made by the said party of the first part on the 27th day of June, A. D. 1911,

did on the 8th day of July, 1911, make an order confirming said sale, and directing conveyances
to be executed to the said party of the second part; a certified copy of which order of confirmation was recorded in the office of the Register
of Deeds of said Tulsa County, within which the said land sold is situated, on the 19th day
of July, A. D. 1911, in Book 77 on page 398, and which said order of confirmation now
on file and of record in said County Court, and which said record thereof in said Register of Deeds' office, are hereby referred to and made a part
of this indenture.

Now, therefore, the said James H. Kennedy
as the Guardian of the said Charley Cowans, a minor,

as aforesaid, the party of the first part, pursuant to the order last aforesaid of the said County Court, and for and in consideration of the sum of
Two Hundred Sixty-two and 50/100 (\$262.50) DOLLARS,
to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has
granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said party of the second part,
his heirs and assigns, forever, all the right, title, interest and estate of the said
Charley Cowans, a minor,

in and to all the certain lot, piece or parcel of land, situated, lying and being in said County of Tulsa
State of Oklahoma, and bounded and particularly described as follows, to-wit:
The East Half of the North-East Quarter
of Section 13, Township 19 North, Range 10
East,

together with the tenements, hereditaments and appurtenances whatsoever to the same belonging or in anywise appertaining.

TO HAVE AND TO HOLD, All and singular, the above-mentioned and described premises, unto the said party of the second part,
his heirs and assigns, forever.
