## Administrators GUARDIAN'S DEED

THIS INDENTURE, Made the 18th day of October, 1912, Nineteen Hundred and 12, at Tulsa, Okla., State of Oklahoma, by and between L. B. Pence, the duly appointed, qualified and acting Guardian of the Estate of Charles J. Reuter, deceased,

and Dillie J. Samsbury, party of the first part, and the part of the second part:

WITNESSETH, That, whereas, on the 14th day of June, 1912, the County Court, within and for the County of Tulsa, State of Oklahoma, made an Order of Sale, authorizing the said party of the first part to sell certain real estate of the said Charles J. Reuter, deceased, situated in the County of Tulsa, State of Oklahoma, described in said order of sale,

And, whereas, under and by virtue of said Order of Sale, and pursuant to legal notices given thereof, the said party of the first part, on the 9th day of August, A. D. Nineteen Hundred and 12, sold the hereinafter described real estate specified and described in said Order of Sale, subject to confirmation by said Court, for the sum of One Hundred and Sixty Dollars, being the highest and best bidder, and that being the highest and best sum bid.

And, whereas, the said County Court, upon the due and legal return of proper proceedings under the said Order of Sale, made by the said party of the first part on the 15th day of August, A. D. 1912,

did on the 26th day of August, 1912, make an order confirming said sale, and directing conveyances to be executed to the said party of the second part; a certified copy of which order of confirmation was recorded in the office of the Register of Deeds of said Tulsa County, within which the said land sold is situated, on the day of A. D. 1912, in Book on page, and which said order of confirmation now on file and of record in said County Court, and which said record thereof in said Register of Deeds' office, are hereby referred to and made a part of this indenture.

Now, therefore, the said L. B. Pence, as the Guardian of the said estate of Charles J. Reuter, deceased,

as aforesaid, the party of the first part, pursuant to the order last aforesaid of the said County Court, and for and in consideration of the sum of One Hundred and Sixty Dollars, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said party of the second part, heirs and assigns, forever, all the right, title, interest and estate of the said Charles J. Reuter, deceased,

in and to all the certain lot, piece or parcel of land, situated, lying and being in said County of Tulsa, State of Oklahoma, and bounded and particularly described as follows, to-wit:

Lot Sixteen (16) in Block Twelve (12) in the Hall and Elliott Addition to the City of Tulsa, Okla.

(This deed is made to consist a deed from the party of the first part to Personal E. Magee, dated August 26, 1912, conveying the above described property.)

together with the tenements, hereditaments and appurtenances whatsoever to the same belonging or in anywise appertaining.

TO HAVE AND TO HOLD, All and singular, the above-mentioned and described premises, unto the said party of the second part, heirs and assigns, forever.
