The south half of the Southeast Quarter (S/2 of SE/4) of section thirty two (32) Township Eighteen (18) North, range Thirteen (13) East, and North Half of Northeast quarter (N/2 of NE/4) of section Five (5) Township Seventeen (17) North, Range Thirteen (13) together with all their right, title, interest and estate in and to the oil and gas under said above described lands, which said lease hold estate is evidenced by a certain oil and gas mining lease made by Nina Snider, and Frank Snider, her husband, lessors, to the parties of the first part herein, dated the 16th day of July, 1910, and recorded in the register of deeds office in Tulsa County, Oklahoma, in record No. 90, on page 212, which said lease, together with all the privileges and immunities therein contained is included in and passes by this assignment.
