#### Contract for Division of property.

Witnesseth, that said parties having this day agreed to separate and live apart and likewise agreed upon a division of their property both real and personal hereby make the following division of said property:

The said Henry C. Armstrong this day executing unto Annie L. Armstrong a warranty deed on the following described property: The East Half of the Northwest quarter and the Northwest quarter of the Northwest quarter of Section 14, Township 19, North, range 14 East, in Tulsa County, Oklahoma, and in addition thereto paying unto her the sum of \$50.00, and the rent on the above described premises for the year 1910; that the above described property is accepted by said Annie L. Armstrong in full satisfaction of all claims either of dower or alimony.

The said Annie L. Armstrong this day executing unto the said Henry C. Armstrong a warranty deed to the following described property to wit: The South East Quarter of Section 11, Township 19 North, range 14 East, being the allotment of Maysie Wright, upon which land described property there is a mortgage of One Thousand Dollars, which the said Henry C. Armstrong hereby assumes and agrees to pay
