

his heirs and assigns, said lease providing for a payment of \$1.00 per acre as bonus and 1/8 of the oil produced therefrom and also for \$150.00 each year for each gas well drilled thereon;

And it further appearing to the Court that said leases are in due form and are equitable and just and that said amounts of bonus money are the highest sums that can be received for leases on said lands, and that said lands are now regarded by oil men as "wild Cat" territory;

And it further appearing to the Court that this Court has full jurisdiction of this cause.

It is therefore by this court ordered, adjudged and decreed that the leases this day executed by the said A.H. Collins as guardian of Albert H. Ely H., Augusta B. Thomas J., Annie and Bessie Collins, minors, on the following described land, to-wit:

The S $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 6, Township 20 N., Range 13 E. The S $\frac{1}{2}$ of of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ and the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ and the E $\frac{1}{2}$ of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 36, Township 31 N. The NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 36 Township 21 N. Range 12 E., Tulsa County, Oklahoma;

said leases being executed to S. Rabinovitz, his heirs and assigns, to be and the same are hereby ratified, approved and confirmed and the said A.H. Collins as guardian of said minors above mentioned is hereby directed to deliver said leases to the said S. Rabinovitz upon his paying the amount of bonus mentioned in said leases.
